Houston Engineering – Mike Ferrie and Zach Herrmann met virtually with project updates.

- Drain 7 -proposal to remove the two current overflow culverts and install new overflow at higher elevation, modify current outlet to larger outlet, discussion on the 25 year event for overflow and projected costs. The board requested consideration of more economical options. Public meeting will be scheduled for January 28, 2025.
- Drain 78 FEMA Outlet repairs the board reviewed the proposed design to keep the project within the FEMA mitigation funding restraints, discussion on the size of rock and grade of the drop was held. A motion was made by Ted Juhl, seconded by Randall Emanuelson, by vote unanimously carried to approve the design of the Drain 78 outlet repairs as presented and directed Houston Engineering to submit to FEMA/ND DES for approval
- Drain 4 the survey has been completed; work on redesign of the drop will be completed this winter. A scope/fee will be presented in January 2025.
- Drain 67A Berm discussion on the elevation the current berm and potential for raising the berm without other downstream effects. Drain is currently functioning to the design. Houston will research the design of the drain capacity with berm raised versus without to ensure no downstream effects.
- Drain 5 next steps will be engineering estimate for bringing project to vote/permitting, discussion on the need benefit analysis which will be done as a pilot project with RRJB
- Johnson Farms/Gapp complaints discussion on what further investigation is needed for board to make determination.
- Red River Basin meeting is in Grand Forks Zach will be presenting and encouraged board to attend.
- A motion was made by Randall Emanuelson, seconded by William Gunderson, by vote unanimously carried to authorize up to \$2500 for Houston to complete the remaining investigation in the complaint of Johnson Farms against Gapp.

The board discussed the ongoing Canadian Dike Advisory board and need for more active participation from the Pembina County Commission.

The board met with the Pembina County Commission and gave updates on projects as well as potential
legislation. Commission Cull discussed the area of concern of Ben Hannesson along Highway 5 –
Commission will be sending a letter to ND DOT to review the ditch block and requested waterboard to do
the same.
